Essay (250 Marks)

- To be written in the medium or language of the candidate's choice Candidateswill be required to write an essay on a specific topic. The choice of subjects willbe given.
- They will be expected to keep closely to the subject of the essay toarrange their ideas in orderly fashion, and to write concisely. Credit will begiven for effective and exact expression.

Paper-II

General Studies-I (250 Marks) (Indian Heritage and Culture, History and Geography of the World and Society)

- Indian culture will cover the salient aspects of Art Forms, Literature and Architecture from ancient to modern times.
- Modern Indian history from about the middle of the eighteenth century until the present- significant events, personalities, issues

Questions mayutilize the case study approach to determine these aspects. The following broad areas will be covered.

- Human Values lessons from the lives and teachings of great leaders, reformers and administrators; role of family, society and educational institutions in inculcating values.
- Attitude: content, structure, function; its influence and relation with thought and behaviour; moral and political attitudes; social influence and persuasion.
- Aptitude and foundational values for Civil Service, integrity, impartiality and non-partisanship, objectivity, dedication to public service, empathy, tolerance and compassion towards the weaker-sections.
- Emotional intelligence-concepts, and their utilities and application inadministration and governance. Contributions of moral thinkers and philosophers from India and world.
- Public/Civil service values and Ethics in Public administration: Status
 andproblems; ethical concerns and dilemmas in government and
 privateinstitutions; laws, rules, regulations and conscience as sources of
 ethicalguidance; accountability and ethical governance; strengthening of ethical
 andmoral values in governance;
- Ethical issues in international relations and funding; corporate governance.

Note1: Marks obtained by the candidates for all Papers (Paper I-VII) will be counted for merit ranking. However, the commission will have the discretion to fix qualifying marks in any or all papers of the examination.

Note 2: Since 2014 Essay paper has been divided into two sections which carry 125 marks for each section and writing 2 essays, 1 from each section is mandatory. Maximum word limit for each section is 1250 words.

Note 3: The main examination is intended to assess the overall intellectual traits and depth of understanding of candidates rather than merely the range of their information and memory.
